#### WHAT DOES THE FUND INVEST IN?


The Fund's objective is to provide steady income to investors by investing primarily in fixed-income securities. Up to 49% of the Fund's assets may be invested in foreign securities.

# **HOW RISKY IS IT?**

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

# **Risk rating**

AGF Investments Inc. has rated the volatility of this fund as low.

Generally, the rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

#### A WORD ABOUT TAX

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, generally, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

# **HOW MUCH DOES IT COST?**

The following tables show the fees and expenses you could pay to buy, own and sell Series M units of the Fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

# 1. Sales charges

No sales charges are applicable for this series of the Fund. Series M units are intended for certain investors who have a discretionary managed account with their registered representative/registered dealer, with such registered representative/registered dealer having entered into an agreement with AGF Investments in connection with the purchase of applicable Funds, subject to certain minimum initial and subsequent purchase requirements.

# **HOW MUCH DOES IT COST? CONT'D**

#### 2. Fund expenses

You do not pay these expenses directly. They affect you because they reduce the Fund's return. The Fund's expenses are made up of a management fee, operating expenses, the Fund's proportionate share of the MER, if applicable, of any underlying fund(s), and trading costs. The series' annual management fee is 0.46% of the series' value. Because this series is new, its operating expenses and trading costs are not yet available.

## More about the trailing commission

No trailing commission will be paid.

#### 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the Fund.

Fee	What you pay
Short-term or frequent trading fee	Up to 2% of the value of securities you sell or switch within 30 calendar days of purchase, or whether there have been multiple redemptions or switches made within 15 calendar days of purchase. These fees go to the Fund.

#### WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
