

# AGF Elements Yield Portfolio Class - Series V

**Before you invest in any fund, you should consider how the fund would work with your other investments and your tolerance for risk.**

Subject to obtaining securityholder approval, AGF is proposing, effective on or about October 1, 2018, to pay certain operating expenses relating to registrar and transfer agency services of this series and, in return, the fund will pay AGF a fixed annual administration fee. A meeting to obtain securityholder approval for this proposal will be held on or about June 14, 2018.

## What does the fund invest in?

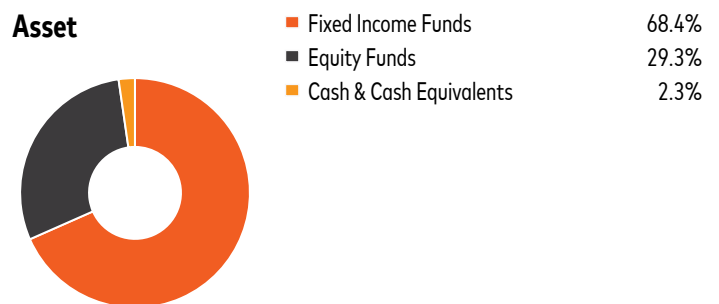
The Portfolio Class's objective is to achieve high current income by investing primarily in a diversified mix of income, bond and equity funds that may include exposure to income trusts, royalty trusts and REITs.

## How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

## Risk rating

AGF Investments Inc. has rated the volatility of this fund as **low**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

## No guarantees

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

## How has the fund performed?

This section tells you how Series V shares of the fund have performed over the past 1 year. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

### Year-by-year returns

This chart shows how Series V shares of the fund have performed in each of the past 1 year. The fund dropped in value in 0 of the last 1 year. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for Series V shares of the fund in a 3-month period over the past 1 year. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### Average Return

The annual compounded return of Series V shares of the fund was 4.1% since inception. If you had invested \$1,000 in the fund since inception, your investment would now be worth \$1,076.

## Who is this fund for?

- you are an income-oriented investor, investing for the medium term
- you are comfortable with low risk
- with respect to Series V securities, you are willing to receive monthly distributions of capital
- you are investing in a non-registered account and want to invest in a fund within a corporate class structure that has significant loss carryforwards that will enable tax-deferred growth

## A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, generally, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series V shares of the fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

You have to choose a sales charge option when you buy the fund. Ask about the pros and cons of each option.

## How much does it cost? cont'd

### 2. Fund expenses

You do not pay these expenses directly. They affect you because they reduce the fund's return. As of September 30, 2017, the series' expenses were 2.10% of its value. This equals \$21.00 for every \$1,000 invested.

<b>Management expense ratio (MER)</b> This is the total of the fund's management fee (which includes the trailing commission), operating expenses and the fund's proportionate share of the MER, if applicable, of any underlying fund(s). AGF Investments Inc. waived some or all of the fund's expenses. If it had not done so, the MER would have been higher.	2.08%

#### More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you.

AGF Investments Inc. pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

Sales charge option	Amount of trailing commission
<b>Front end sales charge</b>	up to 0.75% (\$7.50 for every \$1,000 invested) of the value of your investment each year.
<b>Deferred sales charge</b>	up to 0.25% (\$2.50 for every \$1,000 invested) of the value of your investment for the first 7 years, and up to 0.75% (\$7.50 for every \$1,000 invested) every year thereafter.
<b>Low Load sales charge</b>	up to 0.25% (\$2.50 for every \$1,000 invested) of the value of your investment for the first 3 years, and up to 0.75% (\$7.50 for every \$1,000 invested) every year thereafter.

### 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
<b>Short-term or frequent trading fee</b>	Up to 2% of the value of securities you sell or switch within 30 calendar days of purchase, or whether there have been multiple redemptions or switches made within 15 calendar days of purchase. These fees go to the fund.
<b>Switch fee</b>	Your registered representative may charge you up to 2% of the value of securities you switch to another AGF fund.

## What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
