Management Discussion of Fund Performance

This management discussion of fund performance represents the portfolio management team's view of the significant factors and developments affecting the fund's performance and outlook.

Investment Objective and Strategies

Pursuant to the Declaration of Trust, the investment objective of AGF High Interest Savings Account Fund (the "Fund") is to provide maximum income, while preserving capital and liquidity. To achieve this objective, the Fund invests primarily, directly or indirectly, in high interest deposit accounts with one or more Canadian chartered banks. Indirect exposure is carried out through the use of investment funds that invest in high interest deposit accounts. AGF Investments Inc. ("AGFI"), as portfolio manager, has set and reviews target dynamic allocations between underlying high interest savings accounts at Schedule I Banks for the Fund, consistent with the Fund's investment objective.

Risk

The risks of investing in the Fund remain as disclosed in the current prospectus. Any changes to the Fund over the period have not affected the overall level of risk of the Fund.

The Fund continues to be suitable for investors seeking a higher interest rate on cash deposits and investing for the short-term with a low tolerance for risk. The suitability of the Fund has not changed from what has been disclosed in the prospectus.

Results of Operations

For the year ended September 30, 2024, the Fund returned 4.8% (net of expenses) while the Bloomberg Canada 1-3 Month T-Bill Index returned 5.0%.

As of September 30, 2024, the Fund invested substantially all of its assets in units of High Interest Savings Account Fund (the "Underlying Fund"), which is a fund managed by a third party.

On an expense-adjusted basis, the Fund out-performed the Bloomberg Canada 1-3 Month T-Bill Index. The Underlying Fund invested solely in bank deposits with Schedule 1 Canadian banks, which typically yield higher than 1-3 month treasury bills.

During the reporting period, high interest savings account funds became an increasingly attractive option for Canadian investors as the Bank of Canada's ("BoC") higher interest rates have increased the amount of interest that can be earned from holding these highly liquid assets with short duration. Duration is a measure of the sensitivity of the portfolio to changes in interest rates. Towards the end of the period, however, interest rates on bank deposits have gradually decreased, impacted by the BoC rate cutting cycle.

The Fund had net subscriptions of approximately \$73 million for the current period, as compared to net subscriptions of approximately \$102 million in the prior period. The portfolio manager does not believe that subscription activity had a meaningful impact on the Fund's performance or the ability to implement its investment strategy.

Recent Developments

Canada's economy recorded two consecutive quarters of growth in 2024, after a difficult close to 2023. The unemployment rate in the country gradually climbed, reaching 6.6% in August 2024, while inflation remained largely stable, decreasing to a three-year low of 2.0%. As these trends developed, the BoC implemented three successive interest rate cuts of 0.25% each in June, July and September 2024, bringing its overnight lending rate down to 4.25%, aimed at stimulating economic activity. As a result of these cuts, consumer confidence surged, peaking in August. The manufacturing sector also recorded increased activity in September 2024, the first month of expansion since April 2023, owing to improved domestic demand and new orders.

Headline inflation in Canada decelerated for the third straight month, reaching 2.0% in August 2024 and aligning with the BoC's target for the first time in over three years. The move further indicated that the central bank is in a "cutting phase" in response to easing inflation and a meaningful rise in unemployment.

As of the end of the reporting period, the Canadian yield curve is currently flat to slightly positive, as a result of short-term rates having come down significantly during the last two quarters. Recent economic growth data has come below the BoC's forecast, while the unemployment rate has continued its upward slope, even in the absence of significant job losses. This puts the BoC in a position to continue cutting rates into the end of the calendar year, as inflation is forecasted to remain benign.

Related Party Transactions

AGFI is the manager ("Manager") and trustee of the Fund. Pursuant to the management agreement between the Fund and AGFI, AGFI is responsible for the day-to-day business of the Fund. AGFI also acts as the investment (portfolio) manager of the Fund, managing the investment portfolio of the Fund. Fees payable to AGFI for such services are payable directly by unitholders and are not expenses of the Fund.

AGFI pays for all of the operating expenses relating to the operation of the Fund, except for certain costs as disclosed in the current prospectus, in exchange for a fixed rate administration fee. The administration fee is calculated based on the Net Asset Value of the Fund at a fixed annual rate of 0.32%. Administration fees of approximately \$538,000 were incurred by the Fund during the period ended September 30, 2024.

Explanatory Notes

- (1) a) This information is derived from the Fund's audited annual financial statements. Under International Financial Reporting Standards ("IFRS"), investments that are traded in an active market are generally valued at closing price, which is determined to be within the bid-ask spread and most representative of fair value. As a result, there is no difference between the net assets per unit presented in the financial statements ("Net Assets") and the net asset value per unit calculated for fund pricing purposes ("Net Asset Value").
 - b) The Fund commenced operations in July 2022, which represents the date upon which securities were first made available for purchase by investors.
- (2) Net Assets and distributions are based on the actual number of units outstanding at the relevant time. The increase/decrease from operations is based on the weighted average number of units outstanding over the financial period.
- (3) Distributions were paid in cash/reinvested in additional units of the Fund, or both. The characterization of the distributions is based on management's estimate of the actual income for the year.
- (4) This is not a reconciliation of the beginning and ending Net Assets per unit.

^{*} represents initial Net Assets (1), (2), (3), (4), (5), (6), (7) and (8) see Explanatory Notes

- (5) The management expense ratio ("MER") is calculated in accordance with National Instrument 81-106, based on all the expenses of the Fund (including Harmonized Sales Tax, Goods and Services Tax and interest, but excluding foreign withholding taxes, commissions and other portfolio transaction costs) and the Fund's proportionate share of the MER, if applicable, of the underlying funds and exchange traded funds ("ETFs") in which the Fund has invested, expressed as an annualized percentage of average daily Net Asset Value during the period.
- (6) AGFI waived certain fees or absorbed certain expenses otherwise payable by the Fund. The amount of expenses waived or absorbed is determined annually at the discretion of AGFI and AGFI can terminate the waiver or absorption at any time.
- (7) The trading expense ratio represents total commissions and other portfolio transaction costs, including the Fund's proportionate share of the commissions, if applicable, of the underlying funds and ETFs in which the Fund has invested, expressed as an annualized percentage of average daily Net Asset Value during the period.
- (8) The Fund's portfolio turnover rate ("PTR") indicates how actively the Fund's portfolio advisor manages its portfolio investments. A PTR of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a fund's PTR in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

PTR is calculated based on the lesser of the cumulative cost of purchases or cumulative proceeds of sales divided by the average market value of the portfolio, excluding short-term investments.

Management Fees

The Fund is managed by AGFI. AGFI is responsible for the day-to-day operations of the Fund, which include providing investment and management services as well as other administrative services required by the Fund. The management fees for such services are payable directly by the unitholders, not by the Fund.


Past Performance*
