Management Discussion of Fund Performance

This management discussion of fund performance represents the portfolio management team's view of the significant factors and developments affecting the fund's performance and outlook.

Investment Objective and Strategies

Pursuant to the Declaration of Trust, the investment objective of AGF Global Yield Fund (the "Fund") is to achieve high current income by investing primarily in a diversified mix of income, bond and equity funds that may include exposure to income trusts, royalty trusts and real estate investment trusts. To achieve this objective, AGF Investments Inc. ("AGFI"), as portfolio manager, generally allocates the Fund's assets among underlying mutual funds (the "Underlying Funds") and exchange traded funds ("ETFs"), which are primarily managed by AGFI or an AGFI affiliate. AGFI reviews the Fund's dynamic allocations between income, bond and equity funds quarterly and may adjust the target allocations at any time at its sole discretion, depending on economic conditions and the relative value of equity and fixed income securities. During periods of market downturn, a significant portion of the Fund's assets may be held in cash, money market securities or money market funds.

Risk

The risks of investing in the Fund remain as disclosed in the current prospectus. Any changes to the Fund over the period have not affected the overall level of risk of the Fund.

The Fund continues to be suitable for income-oriented investors investing for the medium term, who prefer regular monthly cash flows that may include a return of capital and who have low tolerance for risk. The suitability of the Fund has not changed from what has been disclosed in the prospectus.

Results of Operations

For the year ended September 30, 2024, the Mutual Fund Units of the Fund returned 13.8% (net of expenses) while the Bloomberg Global Aggregate Index, the MSCI All Country World Index and the Blended Benchmark returned 11.5%, 31.8% and 16.2%, respectively. The Blended Benchmark is composed of 60% Bloomberg Global Aggregate Index/15% Bloomberg Canada Aggregate Index/15% MSCI All Country World Index/10% S&P/TSX Composite Index. The performance of the other series of the Fund is substantially similar to that of the Mutual Fund Units, save for differences in expense structure. Refer to "Past Performance" section for performance information of such series.

The Fund holds Series I Shares/Units or Series Y Units of the Underlying Funds. The discussion below references performance figures for Mutual Fund Shares/Units of the Underlying Funds. The performance of Series I Shares/Units and Series Y Units is substantially similar to that of Mutual Fund Shares/Units, save for differences in expense structure. The Underlying Funds may be subject to valuation adjustments as outlined in the Underlying Funds' valuation policies as they relate to non-North American equities held by the Underlying Funds. A fair value adjustment can either positively or negatively impact the Underlying Funds' rate of return.

The Fund is constructed based on an asset allocation framework that allocates to a diverse array of mutual funds and ETFs representing distinct global asset class opportunities, each with unique risk and return expectations.

The Fund out-performed the Bloomberg Global Aggregate Index due to an out-of-benchmark allocation to equities, which significantly out-performed bonds during the reporting period. The Fund's allocations to global and Canadian equities contributed the most to relative performance. On the other hand, the Fund's selection and allocation decisions within fixed income detracted from relative results. The Fund's allocations to AGF Total Return Bond Fund and AGF US Market Neutral Anti-Beta CAD-Hedged ETF detracted the most.

The Fund under-performed the MSCI All Country World Index due to its allocation to fixed income, as equities significantly out-performed bonds during the reporting period. The Fund's selection within fixed income was a detractor, while selection within equities also detracted from relative performance. The Fund's allocations to AGF Total Return Bond Fund and AGF US Market Neutral Anti-Beta CAD-Hedged ETF detracted the most, while its allocation to AGF Global Dividend Fund contributed the most to performance.

The Fund under-performed the Blended Benchmark due to bond and equity selection, which were partially offset by allocation decisions. The Fund's underweight allocations to global and Canadian equities contributed to overall results. Selection within fixed income detracted from performance. From a holdings perspective, AGF Total Return Bond Fund, AGF Fixed Income Plus Fund and AGF US Market Neutral Anti-Beta CAD-Hedged ETF detracted the most from overall performance. On the other hand, the Fund's allocations to AGF Global Dividend Fund and AGF Canadian Dividend Income Fund positively contributed to relative performance.

During the reporting period, apart from investing in Underlying Funds and ETFs that are managed by AGFI or its affiliates, the Fund also invested in U.S. treasury and ETFs that are not managed by AGFI ("external investments"). The

Fund held approximately 64.0% of its holdings in fixed income funds, 21.0% in foreign equity funds, 7.0% in a Canadian equity fund, 7.0% in external investments and 1.0% cash and cash equivalents as at September 30, 2024. During the reporting period, the Fund's exposure to the various asset types remained fairly consistent, with the exception of an increase to cash and cash equivalents. Within global fixed income, exposure to AGF Global Convertible Bond Fund increased, while exposure to AGF Total Return Bond Fund was reduced. Within global equity, exposure to AGF Systematic Emerging Markets Equity ETF was removed.

The Fund entered into foreign exchange forward contracts during the period under review. As of September 30, 2024, the Fund was long Canadian dollar and short U.S. dollar in order to hedge its indirect currency exposure via the Underlying Funds and ETFs.

Certain series of the Fund, as applicable, make monthly distributions at a rate determined by AGFI from time to time. If the aggregate amount of the monthly distributions made to a series in a year exceeds the portion of the net income and net realized capital gains allocated to series, the excess will constitute a return of capital. The portfolio manager does not believe that the distributions made by the Fund had a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objectives.

The Fund had net redemptions of approximately \$151 million for the current period, as compared to net redemptions of approximately \$71 million in the prior period. The portfolio manager does not believe that redemption activity had a meaningful impact on the Fund's performance or the ability to implement its investment strategy.

Total expenses before commissions and other portfolio transaction costs vary period over period mainly as a result of changes in average Net Asset Values (see Explanatory Note (1) a)) and investor activity, such as number of investor accounts and transactions. Expenses have decreased as compared to the previous period due mainly to a decrease in average Net Asset Values. Custodian fees decreased due to a decrease in market value of investment portfolio and registration fees decreased due to a decrease in subscription activity. The increase in interest expense was due to an increase in overdraft positions throughout the period. The decrease in independent review committee fees was due to variances between the accrued amounts versus the actual expenses incurred in the previous period. All other expenses remained fairly consistent throughout the periods.

Recent Developments

AGFI, as portfolio manager, monitors and reviews the Fund and the strategic asset allocation on a quarterly basis. Rebalancing of the allocation of funds within the Fund occurs quarterly, or as deemed appropriate.

Global equities performed well during the reporting period driven by a resilient U.S. economy. Investors continued to be focused on economic conditions and their ramifications on monetary policy. Higher for longer expectations gradually became consensus through the period, as resilient economic growth and slow progress on inflation kept yields elevated.

The U.S. Federal Reserve (the "Fed") made a significant move in September 2024 by lowering the Fed funds rate by 0.5% to 4.75%-5.00%. This decision marked the beginning of a new monetary easing cycle, which remains data dependent. U.S. economic growth remained resilient over the reporting period and growing at a 3.0% annualized rate as of the second calendar quarter of 2024. Consumer price inflation slowed for the fifth consecutive month to 2.5% in August 2024 yearon-year, below market expectations of 2.6%. This was primarily driven by lower energy costs and easing inflation for food and transportation. Core inflation stood at an over three-year low of 3.2% in August, matching July's figure and aligning with forecasts. Year-on-year personal consumption expenditures ("PCE") inflation came in at 2.2% in August 2024, the lowest since February 2021 and below forecasts of 2.3%. Core PCE inflation also eased over the reporting period, coming in at 2.7% in August 2024 compared to 3.4% in October 2023. The U.S. 10-year treasury yield decreased from 4.57% to 3.78% over the reporting period, and the 2year treasury yield fell from 5.03% to 3.66%. The 10-year versus 2-year treasury yield spread tightened over the reporting period and the yield curve became positively sloped entering September, reflecting growing optimism for longer term economic growth.

Global markets felt some relief during the latter half of the reporting period as central banks in the developed world took a more accommodative stance to their monetary policy. The European Central Bank ("ECB") and the Bank of Canada ("BoC") initiated rate cuts midway through 2024 as inflationary pressures on their respective economies began to ease. Meanwhile, the Bank of Japan tightened its key policy rate at the end of July 2024, which resulted in a resurgent Japanese Yen unwinding global carry trades. Over the reporting period, the conflict in the Middle East continued to be a source of major concern, adding to the existing market volatility, especially impacting the energy sector. While the U.S. equity market continued to perform strongly following the rate cut, softer inflation and labour market data spurred a sector rotation into cyclicals and small capitalization stocks, which are more sensitive to interest rates.

Headline inflation in Canada decelerated for the third straight month, reaching 2.0% in August 2024 and aligning with the BoC's target for the first time in over three years. The central bank announced three back-to-back interest rate cuts of 0.25% in its June, July and September 2024 meetings, bringing its overnight lending rate down to 4.25%. The move further indicated that the central bank is in a "cutting phase" in response to easing inflation and a meaningful rise in unemployment. Despite the expanding consumer base, gross domestic product growth numbers are below the BoC's forecasts, suggesting continued weakness in consumer spending, and the potential need for further rate cuts ahead. Meanwhile, the Canada 10-year bond yield declined from

4.03% to 2.96% and the yield on the 2-year bond dropped from 4.87% to 2.91% over the reporting period, also returning to a positive slope.

Global investment grade and high yield bonds saw positive returns over the reporting period amid a declining inflation profile and stronger-than-anticipated growth in select markets. Credit spreads tightened considerably during the reporting period and most credit categories out-performed government bonds on higher yields versus their safer counterparts.

The ECB reduced the deposit facility rate by 0.25% to 3.50% in its September 2024 meeting to ease monetary policy restrictions. The ECB also lowered interest rates on the main refinancing operations and the marginal lending facility to 3.65% and 3.90% respectively, effective September 18. Previously, the central bank cut interest rates by 0.25% in June 2024 to spur growth in the European Union. Inflation in the Eurozone eased to 2.2% in August 2024, the lowest since July 2021. This resulted from falling prices for energy and slowing inflation for non-energy industrial goods. Core inflation slowed to 2.8% in August 2024 from 4.2% in October 2023. Among the largest economies in the bloc, inflation declined in Germany, France, Italy and Spain during the reporting period. Even though the Eurozone's manufacturing purchasing managers' index ("PMI") rose, factory activity declined in September amid the market downturn in France and Germany, reaching its lowest level in the nine months of 2024. The PMI measures the economic health of the manufacturing sector and is compiled based on new orders, inventory levels, production, supplier deliveries and employment environment. This decline marked over two years of monthly contractions in factory activity in the bloc. The expansion in the services PMI slowed in September, but on the whole, the sector activity continued to expand for the eighth consecutive month.

The portfolio manager believes U.S. markets remain resilient and are supported by a strong, albeit weakening, consumer sentiment and the potential for lower rates. Corporate credit spreads have narrowed significantly over the period and can continue to remain tight if the economy avoids a recession and cash flows hold. It is the portfolio manager's belief that cash yields still provide a competitive rate of return compared to bond yields but will likely diminish as central banks continue to lower their overnight rates. The portfolio manager remains vigilant of flare-ups in geopolitical tensions, which could introduce volatility in energy prices, and inflation.

Related Party Transactions

AGFI is the manager ("Manager") and trustee of the Fund. Pursuant to the management agreement between the Fund and AGFI, AGFI is responsible for the day-to-day business of the Fund. AGFI also acts as the investment (portfolio) manager of the Fund, providing analysis and making decisions as to which Underlying Funds and ETFs the Fund invests in and the target weighting of the Fund's assets. Under the management agreement, the Fund (except for Series O, Series Q and Series W Units, if applicable) pays

management fees calculated based on the Net Asset Value of the respective series of the Fund. Management fees of approximately \$10,758,000 were incurred by the Fund during the period ended September 30, 2024.

Certain operating expenses relating to registrar and transfer agency services are paid directly by AGFI and in exchange, a fixed rate administration fee is payable by the Mutual Fund Series, Series F, Series FV, Series T and Series V Units, as applicable, of the Fund. The administration fee is calculated based on the Net Asset Value of the respective series of the Fund at a fixed annual rate, as disclosed in the current prospectus. Administration fees of approximately \$588,000 were incurred by the Fund during the period ended September 30, 2024.

AGFI is an indirect wholly-owned subsidiary of AGF Management Limited.

Under International Financial Reporting Standards ("IFRS"), investments that are traded in an active market are generally valued at closing price, which is determined to be within the bid-ask spread and most representative of fair value. As a result, there is no difference between the net assets per unit presented in the financial statements ("Net Assets") and the net asset value per unit calculated for fund pricing purposes ("Net Asset Value").

- c) On May 15, 2020, AGF Income Focus Fund merged into the Fund. The financial data of the Fund includes the results of operations of AGF Income Focus Fund from the date of the merger.
- (2) Net Assets and distributions are based on the actual number of units outstanding at the relevant time. The

- increase/decrease from operations is based on the weighted average number of units outstanding over the financial period.
- (3) Distributions were paid in cash/reinvested in additional units of the Fund, or both. The computation of the distributions per unit does not take into account the management fee distributions, if applicable (see note 5 below). The characterization of the distributions is based on management's estimate of the actual income for the year.
- (4) This is not a reconciliation of the beginning and ending Net Assets per unit.
- (5) The management expense ratio ("MER") of a particular series is calculated in accordance with National Instrument 81-106, based on all the expenses of the Fund (including Harmonized Sales Tax, Goods and Services Tax and interest, but excluding commissions and other portfolio transaction costs) and the Fund's proportionate share of the MER, if applicable, of the Underlying Funds and ETFs in which the Fund has invested, allocated to that series, expressed as an annualized percentage of average daily Net Asset Value of that series during the period. For new series launched during the period, the MER is annualized from the date of the first external purchase.

The Fund does not pay duplicate management and advisory fees, as applicable, on the portion of the assets that it invests in the Underlying Funds. Accordingly, AGFI will waive the management and advisory fees payable or paid by the Underlying Funds in order to avoid such duplication.

AGFI may reduce the effective management fee payable by some unitholders by reducing the management fee it charges to the Fund and directing the Fund to make management fee distributions to these unitholders in amounts equal to the amounts of the management fee reduction. The MER does not take into account the reduction in management fees due to management fee distributions to unitholders.

- (6) AGFI waived certain fees or absorbed certain expenses otherwise payable by the Fund. The amount of expenses waived or absorbed is determined annually on a series by series basis at the discretion of AGFI and AGFI can terminate the waiver or absorption at any time.
- (7) The trading expense ratio represents total commissions and other portfolio transaction costs, including the Fund's proportionate share of the commissions, if applicable, of the Underlying Funds and ETFs in which the Fund has invested, expressed as an annualized percentage of average daily Net Asset Value during the period.
- (8) The Fund's portfolio turnover rate ("PTR") indicates how actively the Fund's portfolio advisor manages its portfolio investments. A PTR of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a fund's PTR in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable

capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

PTR is calculated based on the lesser of the cumulative cost of purchases or cumulative proceeds of sales divided by the average market value of the portfolio, excluding short-term investments.

Management Fees

The Fund is managed by AGFI. As a result of providing investment and management services, AGFI receives a monthly management fee, based on the Net Asset Value of the respective series, calculated daily and payable monthly. Management fees in respect of Series O, Series Q and Series W Units, if applicable, are arranged directly between the Manager and investors and are not expenses of the Fund. AGFI uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund's units, investment advice, as well as for general administrative expenses such as overhead, salaries, rent, legal and accounting fees relating to AGFI's role as manager.

Generally, for fund mergers, the continuing fund is considered a new fund for the purpose of calculating rates of return and therefore, the rates of return have not been provided for the period of the merger and previous periods. However, the merger of AGF Income Focus Fund with the Fund (see Explanatory Note (1) c)) and the mergers of Harmony Yield Portfolio and AGF Monthly High Income Fund with the Fund in June 2019




Year-By-Year Returns


Mutual Fund Units



Series F Units




Series FV Units






Series O Units



Series Q Units




