Management Discussion of Fund Performance

This management discussion of fund performance represents the portfolio management team's view of the significant factors and developments affecting the fund's performance and outlook.

Investment Objective and Strategies

As described in the Simplified Prospectus, the investment objective of AGF Total Return Bond Class (the "Fund") is to provide interest income and capital appreciation by investing in debt securities of governments and other issuers around the world. To achieve this objective, the Fund currently invests in units of AGF Total Return Bond Fund (the "Underlying Fund") and may also directly invest in securities similar to those held by the Underlying Fund. AGF Investments Inc. ("AGFI"), as portfolio manager, seeks to maximize the total return of the portfolio through a bottom-up approach to corporate bond selection and a top-down approach to country allocation, category allocation and duration management. A bottom-up investment approach focuses attention on a specific company rather than on the industry in which that company operates or on the economy as a whole. A top-down investment approach involves looking at the "big picture" in the economy and financial world and then breaking those components down into finer details. Duration exposure is the sensitivity of the portfolio due to changes in interest rates. The portfolio manager looks for bond issues that provide an attractive return relative to the risk of each credit. The Fund may also invest in below investment grade government and corporate debt (i.e. credit rating below BBB from Standard & Poor's or equivalent rating from another rating agency). In periods of unusual market conditions, a significant portion of the Fund's assets may be held in cash, cash equivalents or fixed income securities.

Risk

The risks of investing in the Fund remain as disclosed in the current prospectus. The Fund continues to be suitable for investors investing for the medium to longer term and who have low tolerance for risk.

Results of Operations

For the year ended September 30, 2018, the Mutual Fund Shares of the Fund returned -0.8% (net of expenses) while the Bloomberg Barclays Global High-Yield Index and the Blended Benchmark returned 3.8% and 2.7%, respectively. The Blended Benchmark is composed of 40% Bloomberg Barclays Emerging Markets USD Aggregate Index/40% Bloomberg Barclays Global High-Yield Index/20% Bloomberg Barclays Global Aggregate Index. The performance of the

other series of the Fund is substantially similar to that of the Mutual Fund Shares, save for differences in expense structure. Refer to "Past Performance" section for performance information of such series.

The Fund holds Series I Units of Underlying Fund, a fund managed by AGFI. The discussion below references performance figures for Mutual Fund Units of the Underlying Fund. The performance of Series I Units is substantially similar to that of the Mutual Fund Units, save for differences in expense structure.

The Fund under-performed the Bloomberg Barclays Global High-Yield Index due to Underlying Fund's exposure to emerging markets debt and investment grade corporate bonds, both of which generally lagged high yield bonds during the reporting period. Currency volatility triggered by trade risks weighed on emerging markets debt, while higher yields brought on by tighter central bank policy negatively impacted rate-sensitive bonds. The Underlying Fund reduced its exposure to high yield bonds through the reporting period with an expectation that credit quality would weaken late into the economic cycle. However, company fundamentals held relatively strong and default rates remained low, leading to the out-performance of high yield bonds, and as such, served as an obstacle for the Underlying Fund.

The Fund under-performed the Blended Benchmark due to category allocation and hedging effects. The Underlying Fund further reduced its exposure to high yield bonds as the risk/reward trade-off became less favourable. However, the out-performance of high yield bonds relative to the fixed income asset class detracted as the Underlying Fund further reduced its position. The Underlying Fund's hedging effects also detracted in comparison to the Blended Benchmark, which does not actively manages currency risks. The Underlying Fund's net U.S. dollar exposure was reduced in an effort to mitigate foreign exchange volatility, however, the U.S. dollar appreciated through much of the reporting period, serving as a short-term obstacle against the Blended Benchmark.

The Underlying Fund entered into foreign exchange forward contracts during the period under review. As of September 30, 2018, the Underlying Fund was long Canadian dollar and short U.S. dollar in order to hedge its currency exposure.

The Fund had net subscriptions of approximately \$57 million for the current period, as compared to net subscriptions of approximately \$44 million in the prior period. The portfolio manager does not believe that subscription activity had a meaningful impact on the Fund's performance or the ability to implement its investment strategy.

Total expenses before foreign withholding taxes, commissions and other portfolio transaction costs vary period over period mainly as a result of changes in average Net Asset Values (see Explanatory Note (1) a)) and investor activity, such as number of investor accounts and transactions. Expenses have increased as compared to the previous period due mainly to an increase in average Net Asset Values and investor activity. Registration fees increased due to an increase in subscription activity and interest expense increased due to an increase in overdraft positions throughout the period. The decrease in annual and interim reports was due to variance between the accrued amounts versus the actual expenses incurred in the previous period. All other expenses remained fairly consistent throughout the periods.

Recent Developments

The portfolio manager remains constructive towards global growth over the medium term as strong company fundamentals and economic data are supportive. However, trade uncertainty and political turmoil could temper near term returns with periods of unsettled markets along the way.

Trade tensions between the U.S. and China could escalate further, which would weigh on market performance and economic activity. Apart from higher input costs and consumer prices, sentiment around investments and capital expenditure decisions, as well as risk premiums, may also be negatively impacted. The portfolio manager anticipates that an eventual trade agreement between the U.S. and China will ultimately be established, given the high potential costs of the alternative. However, the level of tariffs could worsen in the near term before conditions improve.

U.S. dollar strength has served as an obstacle for global fixed income markets in 2018, particularly for local currency denominated emerging markets debt. In the portfolio manager's opinion, this trend will not be sustained over the longer term and a degree of reversion should take place as trade deficits weigh on the U.S. dollar. This could create an opportunity for local currency denominated emerging markets debt to out-perform.

In the portfolio manager's view, global bond yields will continue to move higher as central banks continue to tighten policy, albeit generally remain range-bound in the near term. While the level of yields is certainly worth monitoring, the pace of such shifts is believed to be the greater threat to market growth.

Within interest rate sensitive bonds, the portfolio manager continues to prefer corporate debt over government issued debt, as corporate debt is expected to be less impacted by rising interest rates in comparison to government debt. Prospects for high yield bonds are less favourable as late-cycle effects begin to wear on credit quality and could lead to spread widening. Near term outlook for emerging markets debt is turning more constructive as select countries appear oversold. Local currency denominated emerging markets debt could benefit from currency reversion if recent U.S.

dollar strength begins to unwind. However, contagion effects from volatile markets and further trade rhetoric could diminish returns.

Effective December 11, 2017, the risk rating of the Fund was changed from "low to medium" to "low". The change reflects compliance with the new Canadian Securities Administrators' Mutual Fund Risk Classification Methodology. No material changes have been made to the investment objective, strategies or management of the Fund.

Effective October 1, 2018, certain operating expenses relating to registrar and transfer agency services are paid directly by AGFI and in exchange, a fixed rate administration fee was introduced for the Mutual Fund Series, Series D, Series F, Series I, Series J, Series T and Series V Shares, as applicable, of the Fund. The administration fee was approved by the shareholders of the Fund on June 14, 2018. The administration fee for each applicable series is calculated daily and payable monthly, based on the average Net Asset Value of the respective series of the Fund at a fixed annual rate, as disclosed in the current prospectus. The Fund continues to pay for all other operating expenses.

Related Party Transactions

AGFI is the manager ("Manager") of the Fund. Pursuant to the management agreement between the Fund and AGFI, AGFI is responsible for the day-to-day business of the Fund. AGFI also acts as the investment (portfolio) manager, managing the investment portfolio of the Fund. Under the management agreement, the Fund (except for Series I, Series O, Series Q and Series W Shares, if applicable) pays management fees, calculated based on the Net Asset Value of the respective series of the Fund. Management fees of approximately \$628,000 were incurred by the Fund during the period ended September 30, 2018.

AGF CustomerFirst Inc. ("AGFC") provides transfer agency services to the Fund pursuant to a services agreement with AGFI. Shareholder servicing and administrative fees of approximately \$39,000 incurred by the Fund were paid to AGFC during the period ended September 30, 2018.

AGFI and AGFC are indirect wholly-owned subsidiaries of AGF Management Limited.

Explanatory Notes

(1) a) This information is derived from the Fund's audited annual financial statements. Under International Financial Reporting Standards ("IFRS"), investments that are traded in an active market are generally valued at closing price, which is determined to be within the bid-ask spread and most representative of fair value. As a result, there is no difference between the net assets per share presented in the financial statements ("Net Assets") and the net asset value per share calculated for fund pricing purposes ("Net Asset Value").

b) The following series of the Fund commenced operations on the following dates, which represents the date upon which securities of a series were first made available for purchase by investors.

(2) Net Assets, dividends and distributions are based on the actual number of shares outstanding at the relevant time. The increase/decrease from operations is based on the weighted average number of shares outstanding over the financial period.

(3) Dividends and distributions were paid in cash/reinvested in additional shares of the Fund, or both.

(4) This is not a reconciliation of the beginning and ending Net Assets per share.

(5) The management expense ratio ("MER") of a particular series is calculated in accordance with National Instrument 81-106, based on all the expenses of the Fund (including Harmonized Sales Tax, Goods and Services Tax, income tax and interest, but excluding foreign withholding taxes, commissions and other portfolio transaction costs) attributable to that series, expressed as an annualized percentage of average daily Net Asset Value of that series during the period.

As a result of the Fund's investment in the Underlying Fund, the MER is calculated based on the expenses of the Fund allocated to that series, including expenses indirectly incurred by the Fund attributable to its investment in the Underlying Fund, divided by the average daily Net Asset Value of that series of the Fund during the period.

The Fund does not pay duplicate management fees on the portion of the assets that it invests in the Underlying Fund. Accordingly, AGFI will waive the management fees payable or paid by the Underlying Fund in order to avoid such duplication.

(6) AGFI waived certain fees or absorbed certain expenses otherwise payable by the Fund. The amount of expenses waived or absorbed is determined annually on a series by series basis at the discretion of AGFI and AGFI can terminate the waiver or absorption at any time.

- (7) The trading expense ratio ("TER") represents total commissions and other portfolio transaction costs expressed as an annualized percentage of average daily Net Asset Value during the period.

As a result of the Fund's investment in the Underlying Fund, the TER is calculated based on commissions and other portfolio transaction costs of the Fund, including such costs that are indirectly incurred by the Fund attributable to its investment in the Underlying Fund, divided by the average daily Net Asset Value of the Fund during the period.

- (8) The Fund's portfolio turnover rate ("PTR") indicates how actively the Fund's portfolio advisor manages its portfolio investments. A PTR of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a fund's PTR in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

PTR is calculated based on the lesser of the cumulative cost of purchases or cumulative proceeds of sales divided by the average market value of the portfolio, excluding short-term investments.

Management Fees

The Fund is managed by AGFI. As a result of providing investment and management services, AGFI receives a monthly management fee, based on the Net Asset Value of the respective series, calculated daily and payable monthly. Management fees in respect of Series I, Series O, Series Q and Series W Shares, if applicable, are arranged directly between the Manager and investors and are not expenses of the Fund. AGFI uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund's shares, investment advice, as well as for general administrative expenses such as overhead, salaries, rent, legal and accounting fees relating to AGFI's role as manager.

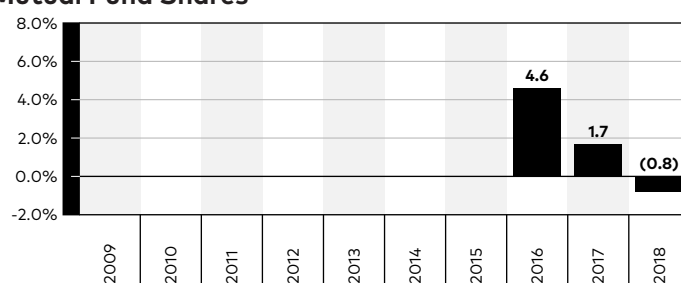
It is AGFI's policy to report rates of return for series in existence greater than one year. The performance start date for each series represents the date of the first purchase of such series, excluding seed money.

Year-By-Year Returns

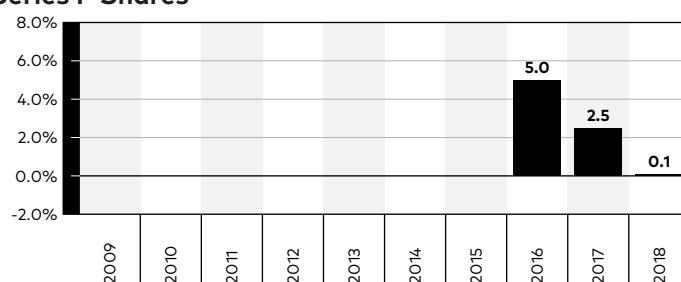

Performance for 2016 represents returns for the period from May 2, 2016 to September 30, 2016.

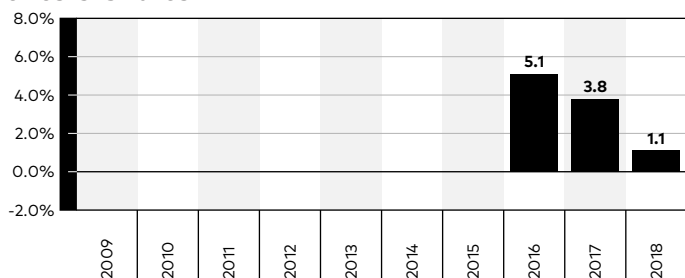

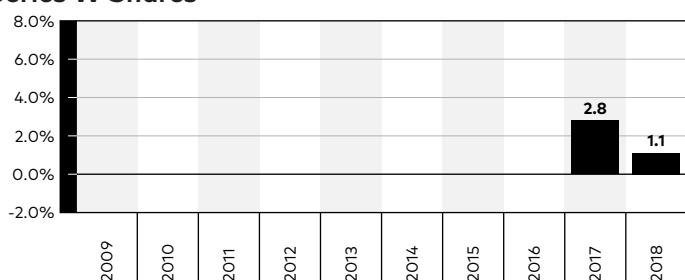
