In this proxy form: "You" and "your" refer to the securityholder (shareholder or unitholder, as applicable) of one or more of these Funds. "Fund" or "Funds" mean a class or classes of AGF All World Tax Advantage Group Limited, and a mutual fund trust or mutual fund trusts, as applicable, for which you are completing this proxy form. "Corporation" means AGF All World Tax Advantage Group Limited, a mutual fund corporation that issues shares. "Trust Fund" or "Trust Funds" means the Funds that are structured as mutual fund trusts and issues units. "We", "us", "our" and "AGF Investments" refer to AGF Investments Inc., the manager of the Funds. "Security" or "securities" refer to shares or units of the Funds, as applicable. "Securityholder" or "securityholders" mean the shareholders or unitholders of the Funds, as applicable.

### PURPOSE OF THIS PROXY FORM

AGF Investments is holding annual and special meetings of shareholders of AGF All World Tax Advantage Group Limited, and special meetings of unitholders of the Trust Funds on **June 26, 2025**, solely as virtual (online) meetings by way of live audio webcast (including any adjournment or postponement thereof, as the case may be, individually, a "Meeting" and collectively, the "Meetings") to vote on the items set out in this proxy form and further described in the management information circular dated May 12, 2025 (the "Circular"). Use this form to:

- vote on the items listed on this form.
- appoint someone other than the named management representatives to vote for you at the Meetings. This person is called a proxy.

This form revokes any and all proxy forms you've previously signed that relate to these Meetings. If there is a discrepancy between the Fund's register and this form about who owns the securities or the number of securities owned, the register will be taken to be correct.

#### This form is valid only if:

- you have signed it, and
- Broadridge Investor Communication Corporation receives it no later than 48 hours (excluding weekends and holidays) prior to the commencement of the Meeting.

#### Securities held in a joint account

Regardless of the number of owners, each of the securities can only be represented by a single vote. If two or more persons own a security, all must vote together as one, either virtually or by proxy.
